Dear Parents & Students,

Thank you for being part of my music studio! I've outlined the following policies to ensure that all students and families have a clear understanding of expectations and procedures. Please read through this agreement and keep a copy for your records.

Tuition & Payment - Monthly Tuition (Billed Sept–May via Fons):

30-minute lessons: \$172/month

45-minute lessons: \$253/month

60-minute lessons: \$341/month

Payment is managed through Fons. You'll receive an invitation to create an account and put a credit card on file. Tuition is billed as a monthly subscription at the beginning of each month. The amount covers (31) lessons from September through May, studio time, and recital planning, divided into 9 even payments for easier budgeting.

April 2026 Absence

I'll be leading a Ukulele Cruise to Hawaii in April 2026 and will be out of town for part of the month. Because of this, I won't be scheduling lessons until late April. The fee for the subscription takes account of my absence.

Missed Lessons & Makeup Policy

If I need to cancel or reschedule a lesson, I will gladly offer you a makeup, reschedule the lesson, or extend future lessons to make up for the lost time—at no extra charge.

No refunds are given for missed lessons.

With more students this fall, I won't have as much flexibility to reschedule lessons that are canceled by the student. Makeup requests will be considered on a case-by-case basis

Instead, I'm excited to offer a creative new option:

If you or I need to miss a lesson, you'll flip into an asynchronous **ChordWise** lesson for that week.

This is part of a new online program I'm developing, with videos, PDFs, and backing tracks—eventually geared toward adult learners. For now, you'll help test out the material during makeup lessons!

Here's how it works:

- I'll send a short video lesson tailored to your instrument (piano, ukulele, or violin)
- After practicing, you'll send me a video of your playing
- I'll reply with feedback via video or email

It's a flexible way to stay on track and help shape something exciting!

Studio Location & Arrival

Please park in my driveway or on McGovern Street (no parking on Deerfield Rd.)

- Use the back door entrance for all lessons
- Be prompt for drop-off and pick-up

Practice Expectations

Consistent daily practice is essential for progress:

Beginning students: 20 minutes/day

Intermediate: 30 minutes/day

Advanced: 45–60 minutes/day

Have a set routine and practice spot!

Bring an assignment notebook to each lesson so I can write down what to practice.

Holidays & Weather

We follow District 112 for major holidays:

Thanksgiving, Winter Break, Spring Break, and Easter.

In case of inclement weather, we'll switch to Zoom or reschedule if possible.

Withdrawal & Extended Absences

If you're considering ending lessons, please talk with me first—we may be able to resolve any issues. If you decide to withdraw, one month's notice is expected so I can fill the time slot.

Performances

There will be two recitals per year, typically in December and May.
